



Vocational Education and Training Network Reflection Report

Trinity Grammar School hosted an exciting initiative to welcome 100 Vocational Education Teachers and Coordinators from across the membership of the Association of Independent School (AIS) at its recent "VET Network Day" on Friday 7 December 2012.



In a year which has already seen so many changes to this exciting and rapidly changing sector, the need to recognise and provide professional development for VET teachers is a crucial element for any organisation in knowing the specific skills that the industry requires. This network day allowed VET practitioners to be more informed about the training packages requirements and industry standards to have a better understanding of their own continuous improvement strategies for training and assessment. The day also allowed the opportunities explore the challenges we face as practitioners in Validation and Moderation in VET and to engage with keynote speakers that have extensive knowledge of the VET sector. VET in schools has grown dramatically since 2001.

This year approx 30 800 students were enrolled in at least one HSC Vocational Educational and Training or VET course. Of these, 19 917 were enrolled in one or more of the VET curriculum frameworks across our schools in NSW and having important events like this day can help to promote best practices in VET in this exciting and rapidly changing sector.







The program content during the day included:

- 1. The opportunity to network and share resources with other VET practitioners across the sessions.
- 2. The opportunity to network through closer association with industry.
- 3. The opportunity to explore pedagogical issues and ways to improve the quality of VET within your school.
- 4. The opportunity to learn how to manage VET processes in your school environment.
- 5. To develop outreach and create opportunities in understanding new ideas, sharing and developing resources and continuous improvement strategies in promoting best practice in vocational education and
- 6. Finally, the opportunity to receive new developments from the AISRTO, the Board of Studies and Industry stakeholders regarding the curriculum requirements and practical mentoring opportunities.








The more **specific aims** of network day included:

- To give all VET Teachers a chance to learn, network and share vocational training information in the friendly environment of a school setting.
- To allow for reflection of the presenters' proposed services in promoting best practices in VET.
- To give the VET Teachers and Coordinators an opportunity to network with other delegates in various industry curriculum frameworks in Auto / Construction / Metals / Primary Industry, Electrotechnology, Entertainment, Hospitality, Business Services / Retail / Financial Services and Information Technology activities.
- To give the VET Teachers and Coordinators an opportunity to establish links with Industry to assist in "real life" educational opportunities learned in class.

- To develop outreach and create opportunities in understanding about new ideas, sharing and developing resources and continuous improvement strategies in promoting best practice in Vocational Education and Training.








The participants enjoyed working with other educators from a variety of schools in providing relevant industry and practical mentoring opportunities. The Network Day was also a form of professional development to help the VET educators to be informed and updated about their VET curriculum requirements. The presenters at this Network Day used a variety of powerful techniques for idea generation, idea evaluation and implementation, which included strategies in VET assessment and validation that educators would need to known for compliance requirements.

Some items of note from the day included:

- A new AIS website has been developed.
- A new AIS VET database is being developed that will record teacher qualifications and professional development hours.
- The AIS is organising writing teams to develop scope and sequences and assessment tasks for Construction and Primary Industries.




